



Professional Conduct Committee
Report to the Discipline Committee on Complaint 2024_C015
February 10, 2025

Pursuant to Subsection 27(3) of *The Paramedics Act*

Description of Complaint

On May 17, 2024, the College was contacted by Mike Bell of La Ronge EMS. Mr. Bell reported that he had been notified by Saskatchewan Blue Cross that Mike Lacourciere, a member of the College on medical leave from La Ronge EMS, had submitted at least 27 fictitious claims under a health insurance policy for health care services that were never rendered.

This complaint was forwarded to the Professional Conduct Committee (“PCC”) for investigation in accordance with subsection 27(1) of *The Paramedics Act*.

Summary of the Investigation

The PCC determined the complaint was against a member of the College and so it had jurisdiction to investigate. The PCC contacted the Member, who was asked for a written statement regarding the complaint.

The Member responded by email on September 29, 2024, saying, in part, that he would not take part in the investigation and that he was not a member of the college. The Member is in fact a member of the College although he is not currently licensed.

Legal counsel for the College wrote to the Member on October 2, 2024 offering him the option to resign in the face of discipline under certain conditions that were outlined in the letter and asking him to confirm that he did wish to resign. The Member did not respond to that correspondence.

Legal counsel wrote to the Member again on November 16, 2024 stating that since he had not responded to the earlier letter the College would treat his September 29, 2024 response as an application to resign his membership in the College. He did not respond to that correspondence.

On February 7, 2025, the Council of the College met and unanimously voted to accept the Member’s resignation in the face of discipline.


Recommendation to the Discipline Committee






